* IFA DOES NOT PROVIDE LOAD OR UNLOAD SERVICES. THE SHIPPER IS RESPONSIBLE FOR THIS. IN THE EVENT THAT THE PERSON UNLOADING IS NOT PRESENT UPON ARRIVAL THE IFA WILL REMOVE THE VEHICLE AND FEES OR COSTS ASSOCIATED WITH THIS REMOVAL MUST BE PAID BEFORE THE VEHICLE WILL BE RELEASED (see Terms below).

THE PERSON PICKING UP VEHICLE MUST BE AVAILABLE TO UNLOAD VEHICLE AT LEAST 15 MINUTES PRIOR TO SCHEDULED ARRIVAL OR A \$50 UNLOAD PENALTY WILL BE CHARGED.

INTER-ISLAND FERRY AUTHORITY UNACCOMPANIED VEHICLE TERMS AND AGREEMENT

1. The Shipper of the unaccompanied vehicle is responsible for the loading and unloading of his/her vehicle. The Inter-Island Ferry Authority does not provide this service.
2. The vehicle keys MUST accompany the vehicle. The person loading the vehicle is responsible for leaving the vehicle keys in the possession of the IFA Master or Chief Mate of the vessel. If the keys do not accompany the vehicle and it must be moved or removed, the cost of such movement will be borne by the person picking up the vehicle at its destination.
3. If the Shipper does not provide for the removal of the vehicle promptly upon arrival at the destination port, the Inter-Island Ferry Authority will have the vehicle removed in one of three ways at the discretion of the IFA Master on duty: i) IFA personnel will remove the vehicle and a \$50.00 unload penalty charge will be collected prior to release of the vehicle. ii) A commercial towing company will be called to remove the vehicle, and the total charges for towing service and a \$50.00 unload penalty charge will be assessed and collected prior to the release of the vehicle. iii) The vehicle will remain onboard the vessel and appropriate charges will be assessed and collected for all additional transportation incurred until the vehicle is removed, and a \$50.00 unload penalty charge will be assessed and collected prior to the release of the vehicle.
4. The Inter-Island Ferry Authority shall not be responsible for unaccompanied vehicles or their contents. The Shipper puts the vehicle and anything in the vehicle on the IFA vessel solely at his/her own risk, and the Shipper assumes and accepts full responsibility for all damage or loss.
5. I hereby for myself, and on behalf of my heirs, executors, administrators and personal representatives, do waive, release, and forever discharge the Inter-Island Ferry Authority, its employees, board members, officers, representatives and attorneys from and against any and all liability and all claims, actions, causes of action, costs, expenses and demands of any damage, loss, death or injury arising out of, or in connection with my shipment of an unaccompanied vehicle on an IFA ferry.
6. I hereby agree to defend, indemnify and hold harmless, the Inter-Island Ferry Authority and its employees, board members, officers, representatives, attorneys and insurers in any action of any kind and any nature from and against any and all liability and all claims, actions, causes of action, costs, attorneys fees, expenses and demands of any damage, loss, death or injury arising out of, or in connection with my shipment of an unaccompanied vehicle on an IFA ferry. I agree that this Document and all other aspects of my relationship with the IFA are exclusively governed by Alaska State Law. I agree that Jurisdiction and Venue for any action of any kind and any nature, or any other proceeding arising out of or relating to my shipment of an unaccompanied vehicle on an IFA ferry shall be exclusively in the Superior Court for the State of Alaska, First Judicial District at Craig, Alaska.

I have read, understand and agree to the terms of shipping my unaccompanied vehicle. I clearly understand this agreement and waiver and indemnification agreement and agree to its terms, and that I am freely and voluntarily executing this agreement. I further acknowledge and agree that I have consulted with an attorney of my choice or have had the opportunity to consult with an attorney of my choice before signing this agreement. I acknowledge and agree that I am not relying on the representations of any agents, owners, employees, volunteers, or representatives of the IFA in signing this acknowledgment and assumption of risks and release and indemnity agreement. I acknowledge that this agreement shall be effective and binding upon myself, my spouse, my family, my heirs, executors, representatives and estate.
